UNFINISHED BUSINESS

Nominating Committee:

Cheryl Landry had to withdraw from the committee for Region 1. On April 8, 2025, the Board responded unanimously in the affirmative for Ellie Pieper to fill this vacancy.

The committee met for the final time on April 17. They completed and voted on a slate of candidates. The Committee Chair sent the list to the Recording Secretary per the Club Bylaws.

2025 National:

Kami, Celestia and Ailynn researched companies that provide promotional materials and apparel and found a potential candidate that offers a wide variety of products. The Show committee members are testing the quality of some of the products.

There was a discussion on the markup on products.

Celestia found some trophy charms from Woodbury Pewter. Jacqueline offered to try to negotiate a competitive price for the Club.

There will be some nice trophies for the Devon and Hatboro supported entries.

Constitution and Bylaws Update:

The AKC approved the first draft of the Constitution and Bylaws as presented. On the advice of the AKC, since we are currently in the process of reincorporating in the state of Illinois, Jacqueline sent the draft to Illinois attorney, Eugenia Hunter, for review.

Eugenia's response stated that she had reviewed them and that "the proposed bylaws amendments and noticed that the AKC provisions for written ballot to be done electronically was not included. Those should be revised to include that if you are going to this trouble. Saves time and money. Provisions were included for the board to conduct virtual meetings."

Jacqueline reached out to the AKC (Christa Vat and Aneke McPhail) for help with the exact wording and placement in the already approved draft so that we don't have to go back and forth until we get it right. They recently responded with what to do. Jacqueline will continue working on this.

Judges Selection:

Ballots will go out soon along with other materials from the Board.

Update on BPCA Incorporation and Merger to Illinois:

Attorney Eugenia Hunter will continue working on this taking into account the recent response from the AKC concerning what needs to be done to update the Constitution and Bylaws regarding virtual meetings.

2025 Trophy Donations:

This topic was not discussed at the meeting.

2026 National Specialty:

Purina is not responding to Jacqueline. We will move this National Specialty to Des Moines by default. Nancy is moving forward with this.

2027 National Specialty:

Ailynn sent information to the Board about different location in Colorado. She will send this information to the Board again.
